1 Completed Application Form (Form 1) and Application Assessment Fee (as quoted) **MUST** be paid at time of application (will be deducted from final permit fee). Note: the application form must include owner and builder details plus the estimated cost of works. ☐

2 Letter of Appointment (to be signed by owner/s). ☐

3 Provide a current copy (within last 90 days) of the Certificate of Title and Plan of Sub-division for the allotment including any applicable Covenants or Section 173 Agreements including evidence of ownership. ☐

4 Town Planning inquiry from the relevant council (letter or details of person in Council you have spoken with). If a Planning Permit is required, provide two copies of the Town Planning Permit and endorsed drawings. ☐

5 Legal Point of Discharge Advice under Reg 133 obtained from Council. ☐

6 Provide a copy of the Property Information, under Reg 51(2), that applies to the allotment. **This information must be obtained from Council** and must contain the information relating to flooding under Reg 153 and 154. ☐

7 Working Drawings and Specifications:
 - Site area calculations including permeable areas of the allotment
 - Car parking provisions
 - North position
 - Show position, size and type of windows on adjoining allotments
 - Shadow/overlooking diagrams
 - Existing conditions
 - All dimensions and setbacks to boundaries
 - Elevations showing wall heights
 - Sections showing ceiling heights
 - Floor levels/step heights
 - Location/width of easement/s
 - Wall types and flooring ☐

8 Engineering Drawings, Computations, Wall Bracing Design and Certification. For multiple units on a site, storm water drainage design will also be required. ☐

9 Energy Efficiency 7-Star Report and stamped plans. Solar HWS or 2000lt Rainwater Tank connected to all flushing toilets required for all new dwellings. ☐
